In response to the Govt. letter above, where in you have expressed willingness to provide services under SAG in ICDS Project, your NGO's is hereby requested to provide SAG services by procuring food stuff for delivering the same to the office godown of concerned Child Development Project Officers indicated in the Annexure-I enclosed herewith. The enclosed Annexure-I contains project wise details of food items and quantity to be delivered. The procurement and supply work will have to be completed within 60 days from the date of receipt of this letter without fail. After delivery of food stuff in the office godown of the concerned CDPOs, receipt challan and bills will have to be obtained from the CDPOs where in the CDPOs will have to certify to the effect that the food items have been received in good condition, and full quantity and entered in the Stock Book No..... at page No.....

The CDPOs and his/her functionaries and the Anganwadi Centers management Committee shall endeavor to mobilize resources by way of community contribution (fruits, vegetable, cereals, etc. which are locally available and have protein, calorific and micronutrient value.

The food stuff indented vide this order is exclusively meant for Adolescent Girls (out of school) of the age group 11 years to 14 years, in the ICDS Project shown as per enclosed Annexure-I.






